Comprehensive plan passes

On June 14, the City Council adopted a new comprehensive plan for Dallas. The plan establishes broad policy choices and procedures to guide the City for the next 20-30 years.

Many compare a comprehensive plan to a constitution because it establishes a conceptual framework within which a City must operate on a day-to-day basis. In fact, Texas law requires that when the City adopts any zoning ordinance, the zoning ordinance must conform to the comprehensive plan.

The plan addresses eight overlapping subjects, including Land Use, Housing, Environment, Neighborhoods, Transportation and Urban Design. Each subject sets out guiding policy choices.

For example, the transportation section addresses mass transit and proposes locations for future transit centers similar to Mockingbird Station. The environmental section addresses choices for storm-water management and new construction using energy-efficient technology. The neighborhood element discusses neighborhood stabilization.

The initial draft of the plan was criticized for its lack of public input, incompleteness, and errors. However, neighborhood activists and developers worked to get favorable changes made to the plan. Also, the City Plan Commission adopted a consensus document that was reflective of the public's more significant expressed concerns and goals.

The City Council put passage of a comprehensive plan on a "fast track," and over the objections of many in packed City Council chambers, the Council chose to remove many of the Plan Commission's changes friendly to established neighborhoods. District 14 Councilmember Angela Hunt sought to keep the Plan Commission's changes but was out-voted.

In the coming months and years, LGNA residents should be vigilant for land-use changes resulting from the new plan. In particular, the new plan designates Lower Greenville Avenue as a "Main Street." The implication of this designation is not fully clear, but it could mean taller, denser commercial or retail development fronting on Greenville Avenue. Another area of interest will be possible changes in parking standards as those standards are revisited throughout the City.

Greenville Avenue parking

On May 23 Councilmember Angela Hunt held a meeting for neighborhood residents, landlords, and businesses to discuss re-allocation of parking spaces on Greenville Avenue. Three new restaurants have requested that they be allowed to remove parking spaces and extend the sidewalks in front to allow for sidewalk café use.

The property owner feels that new valet-parking spaces will compensate for the lost street parking. Others believe that there was a deficit of more than 1500 parking spaces before rooftop patios were added in recent years. No parking spaces were added when the rooftop patios were added, increasing the deficit.

The fire on June 21 most certainly will impact the nature of the situation. It is commonly accepted that lack of parking on Greenville Avenue impacts the quality of life in residential areas. A thoughtful re-building of the affected area will involve input from LGNA and other neighborhood associations representing local residents.

Belmont-Matilda stop sign

The new four-way stop sign with flashing red light has been installed at the corner of Belmont and Matilda. Thanks to Officer Keith Allen, Councilmember Angela Hunt, and the City's Public Works Department for following through and getting results on this important safety measure. At a Lower Greenville Crime Watch meeting, Officer Allen learned of neighborhood concern about the high accident rate at the intersection and followed through with effective action.

Information from Councilmember Hunt's office on May 31 quoted City sources: "A review of police accident reports over the past three years revealed a high number of right-angle accidents." "Belmont is one block from the traffic signal at Richmond and Matilda. We are worried that drivers on Matilda will not expect to stop one block after passing through the traffic signal. We are going to install a red flasher so drivers will not miss the stop sign."

Alley clean up

May 6's Crime Watch-sponsored alley clean-up between Palo Pinto and Velasco was very successful. Almost 20 volunteers came out and removed trash and overgrowth. Two construction dumpsters were filled to overflowing with debris.

Volunteers were treated to a hot dog lunch courtesy of Claudia Worme, Victor Aves/Pegasus Realty, Darren Dattalo/Abio Realty, and LGNA. DPD Officer Keith Allen gave information on crime issues on Lower Greenville and suggestions for alley security.

Officer Allen suggested motionsensitive lighting and posting house numbers in the alley. Both allow police to find homes when a crime or suspicious activity is reported. LGCW is looking into sources for these items as part of National Night Out.

Possible is a bulk discount on motion lights which could be ordered or purchased at NNO. LGCW is also looking into posting house numbers in alleys as part of a community-service project with a local high school or Boy Scout troop.

Meanwhile, don't hesitate to post house numbers in the alley yourself!
